FIELD STAFF DASHBOARD - DEVELOPMENT

The VAIRRS Workgroup was developed to **provide site level feedback** regarding the use of the IRBNet. Results from the feedback collected from the VAIRRS Workgroup provided insight into the demands of IRBNet users and ultimately a more tailored set of dashboards for the field's use.

The focus groups were held virtually during the summer of 2021.

- 94 participants were pooled from the following roles within the VA:
 - Associate Chiefs of Staff, Administrative Officers
 - IRB Chairs, Members, Coordinators
 - Research & Development Committee Chairs, Members, Coordinators
 - Research Compliance Officers


