"As you may know, the Cancer Moonshot 2.0 has been receiving a lot of attention within VA given our leadership and capabilities, particularly in research. I would like to make sure you are aware of the following funding opportunity by the Hope Foundation to establish a "Storefront" that will encourage more Southwest Oncology Group cancer clinical trials to be done in VA. "VHA Leadership have been very supportive in our efforts to enhance opportunities for more cancer trials in meeting transformative goals for increasing the integration of cancer care and trials within VHA. VA has had a successful Storefront model in VISN 1 and the hope is that more VISNs/VAMCs will consider this new opportunity to be connected with these efforts under the Moonshot. Furthermore, any successful application will be linked with the National Cancer Institute-VA partnership called NAVIGATE which has received Congressional support in their research appropriation to VA.

ORD DEI-sponsored Summer Research Programs Kick-off

In June, the first-ever ORD-sponsored Summer Research Program (SRP) welcomed 105 student participants at 21 VA sites across the country.

This program is a cornerstone of ORD's efforts to strengthen and diversify the VA scientific work force by offering research experiences to Veterans, children of Veterans, and underrepresented students at the high school level and above. Of note, the inaugural cohort of students include 64 college students, 8 graduate students, 11 high school students. VA is proud to welcome these future scientists and contributors to a proud, 95-plus year research tradition.
